ADVERTISING AGREEMENT

This Advertising Agreement (the "Agreement") is made and entered into this ____ day of _____, by and between the Owasso Baseball Booster Club ("Booster Club") whose address is P. O. Box 1011, Owasso, Oklahoma 74055 and _____ ("Company"), whose address is _____, 74_____. For good and valuable consideration, Booster Club and Company hereby agree as follows:

1. **Signage.** Booster Club hereby leases to Company and Company hereby leases from Booster Club one 8' x 12' advertising sign (the "Sign") on Space No. ____ at the Owasso H. S. Varsity Baseball Field outfield fence.
2. **Materials/Preparation.** Company shall provide Booster Club with a camera-ready layout for the Sign including design, colors, layout, graphics, content and logos, all of which shall be subject to the approval of the Booster Club and the Owasso School Board. Booster Club shall be responsible for the construction, painting, application and maintenance of the Sign.
3. **Price.** Company shall pay Booster Club the total sum of \$1,500.00 for the sign, which sum shall be due and payable as follows: \$500.00 upon execution of this Agreement, \$500.00 on _____ and \$500.00 on _____. Any sums not paid when due shall bear interest at the rate of eighteen percent (18%) per annum. In lieu of making the annual payments of \$500.00 for three years, Company may prepay for all three years of this Agreement by payment of the sum of \$1,200.00 upon execution of this Agreement.
4. **Term.** This Agreement shall remain in effect for three (3) calendar years commencing on the _____ day of _____, _____, and expiring on the _____ day of _____, _____.
5. **Renewal Option.** During the last 6 months of this Agreement, Company shall have the right to renew this Agreement for one additional three-year term upon the same terms and conditions set forth herein (except that additional rights of renewal shall be subject to the agreement of the Booster Club) by delivering written notice of Company's intent to exercise this Renewal Option to the Booster Club at the address listed above prior to expiration of the original term of this Agreement.
6. **Attorney's Fee and Costs.** In the event that either party hereto is required to commence litigation to enforce the terms of this Agreement, the prevailing party shall be entitled to recover from the other party its court costs, expenses and a reasonable attorney's fee.
7. **Authority/Binding Agreement.** The individual executing this Agreement on behalf of Company represents and warrants to Booster Club and he/she is fully authorized to execute this agreement and that the same shall be binding upon Company.
8. **Miscellaneous.** This Agreement shall be binding upon the parties hereto, their respective successors and assigns. This Agreement may not be amended *except* in writing duly executed by the party to be charged therewith.

IN WITNESS hereof, Booster Club and Company have executed this Agreement the day and year first above written.
